- ensuring that the school's money is well spent

GOVERNOR VACANCIES

OFSTED

During the last academic year, the school received 3 Ofsted inspection visits. The effectiveness of the Governing Body is also inspected during these visits and governors were required to speak to the Ofsted inspectors during the visits made in January and May 2021. The inspection reports state:

- Governors are checking that leaders are taking appropriate action to ensure that pupils are receiving an education. They are mindful of leaders' workload, especially during the current circumstances.
- Governors acknowledge that their usual approach to monitoring the work of leaders has been hindered due to COVID-19 restrictions. They have been unable to make regular visits to school. However, they have sought training that supports them in asking challenging questions of leaders. This enables them to evaluate the impact of the actions leaders are taking.

GOVERNORS' MEETINGS

The full Governing Body meets twice each term and we also have a Teaching and Achievement Committee and a Staffing and Resources Committee which both meet once during the term. Due to coronavirus restrictions, all of our Governors' meetings during the last academic year were held virtually so that governors were still able to fulfil their leadership and management role.

Here are just some of the areas that we discussed and made decisions on during the year:

- attendance
- behaviour
- attainment and progress
- ensuring a broad and balanced curriculum
- staffing structure
- safeguarding
- budget forecasts and allocation of funding
- actions taken to address the school's improvement priorities

GOVERNOR TRAINING

Governors regularly undertake training and attend courses to help them to carry out their leadership and management role effectively. During the past academic year the training and courses attended and undertaken included:

- curriculum training to enable governors to support and challenge the school and ensure that the
 curriculum it provides follows National Curriculum requirements, builds on previous knowledge
 and skills, has been shaped to meet the needs of all pupils based on their backgrounds and prior
 experiences and builds in assessment to track the progress of pupils
- training on how to become an evidence informed governor
- courses on on-line safety and records management
- training on how to conduct virtual governor visits

All governors are also required to regularly update their Safeguarding, Prevent (safeguarding and supporting those vulnerable to radicalisation) and Data Protection training.
